This program focused on strengthening civil society, developing emerging leaders, promoting freedom of religion or belief and other fundamental human rights, and building the capacity of local faith and community networks to respond to the needs of vulnerable populations. A significant accomplishment was OAA's SNAP leadership training initiative, through which 24 emerging Cuban leaders received direct training designed to strengthen their leadership, organizational, and community engagement skills. These participants subsequently conducted replica training sessions within their own communities, extending the program's reach to approximately 170 additional beneficiaries. This multiplier approach expanded the impact of the original training while developing local capacity and enabling knowledge and skills to be transferred through Cuban-led networks.
